Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed By

Staff Archivists, June 2019. Previously restricted materials are added as they are released.

System of Arrangement

Records that are responsive to this FOIA request were found in four collection areas—Bush Presidential Records: WHORM Subject Files; Bush Presidential Records: Staff and Office Files; Bush Vice Presidential Records: Staff and Office Files. As policy, WHORM Subject Files are processed at the document level. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this

method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at http://bushlibrary.tamu.edu/research/find/whorm/whorm.html.

Please note that a single asterisk "*" indicates that the category is entirely processed and open.

Scope and Content

The materials in FOIA 2018-0984-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

The Presidential WHORM Subject File categories contain correspondence, forms, memoranda, newspaper articles, and questionnaires. Records include articles forwarded from the Manchester Union Leader regarding President Bush and Chief of Staff John Sununu. Correspondence conveys invitations and good wishes. There is also a questionnaire from the Union Leader prior to the 1992 election.

The Office of Political Affairs, Ron Kaufman Files, contain previously processed records related to correspondence from the Manchester Union Leader.

The Vice Presidential WHORM Subject File categories contain correspondence, newspaper articles, and tracking forms. These records relate to the Vice President's attendance and speech at a tribute to William Loeb in 1985.

The Vice Presidential Staff and Office Files contain audiocassettes, forms, invitations, memoranda, notes, and schedules maintained by individual staff members and offices. Barbara Bush's Event Files consist of memoranda and schedules for the Tribute to William Loeb Dinner held on December 11, 1985. The Press Office files hold an audiocassette of an interview the Vice President gave to the Manchester Union Leader. The Scheduling Office files comprise invitation, notes, tracking forms, and transmittal memoranda regarding the Tribute to William Loeb Dinner.
