### **Scope and Content**

The materials in FOIA 2018-1296-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2018-1296-F contains correspondence relating to a congratulatory message from President George H. W. Bush to the first United States National Women's Ice Hockey Team.

The WHORM Subject File category contain letters, forms, notes, drafts, and memoranda, used in preparing a presidential message to the first United States National Women's Ice Hockey Team as they competed in the first World Championship for women's ice hockey March 19–25, 1990, in Ottawa, Ontario, Canada. Additionally, a letter, magazine, and newspaper articles highlight the development of women's ice hockey in the United States.
