#### **Access**

Access to Bush Presidential Records, Bush Vice Presidential Records, and Quayle Vice Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

### **Provenance**

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

#### **System of Arrangement**

Records for this systematic project were found in two collection areas—Bush Presidential Records: WHORM Subject Files; and Bush Vice Presidential Records: Staff and Office Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. #### **Scope and Content**

The materials in Case Number 2019-0004-S are a systematically processed body of documents responsive to the topic. Researchers should consult the archivist about related materials.

Systematic Request 2019-0004-S contains materials related to the attempted assassination of President Reagan in 1981. The processed records are located in the Bush Presidential WHORM Subject Files and the Bush Vice Presidential Press Office, Peter Teeley Files, Press Release Files.

The WHORM category records consist of a FOIA request for materials related to the assassination attempt and the resulting documents, a note returning the draft statement for Vice President Bush, the draft statement, and a press briefing.

The Staff and Office Files contain a note returning the draft statement for the Vice President, the draft statement itself, and a press briefing by Vice President Bush, Larry Speakes, and David Gergen.
