Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed By

Staff Archivists, April–August 2019. Previously restricted materials are added as they are released.

System of Arrangement

Records that are responsive to this FOIA request were found in four collection areas—Bush Presidential Records: WHORM Alphabetical Files; Bush Presidential Records: WHORM Subject Files; Bush Presidential Records: Staff and Office Files; Bush Vice Presidential Records: Name Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental

processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at <u>http://bushlibrary.tamu.edu/research/find/whorm/whorm.html</u>.

Please note that a single asterisk "*" indicates that the category is entirely processed and open.

Scope and Content

The materials in Case Number 2019-0343-S are a selective, not necessarily all inclusive, body of documents responsive to the topic. Researchers should consult the archivist about related materials.

Case Number 2019-0343-S contains materials from agencies and individuals regarding William Pelham Barr who was nominated and appointed as United States Attorney General during the George H.W. Bush administration. Attorney General Barr served in this position from November 26, 1991 until January 20, 1993. A substantial amount of material found in the collection relates to his nomination process for this position. The other positions held by Attorney General Barr during the Bush administration were United States Assistant Attorney General for the Office of Legal Counsel and United States Deputy Attorney General.

The White House Office of Records Management (WHORM) Alphabetical Files contain letters from the general public and the administration offering opinions, congratulations, and letters of recommendation for the potential candidates, and William Barr, for several posts in the administration.

The WHORM Subject File categories contain talking points, memoranda, news clippings, and correspondence from the general public, Congress, and the Bush administration mentioning William Barr. Two of the larger responsive categories are WHORM Subject File category FG017 (Department of Justice) and FG053 (District Courts).

The Staff and Office Files consist of memoranda, transmittal slips, press releases, notes, cover sheets, letters, draft opinion papers, speech cards, policy documents, distribution receipts, NSC profile sheets, talking points and newspaper articles. The majority of these records pertain to the nomination, process of appointing, and swearing-in of William Barr as Attorney General and a collection of news summaries compiled for his review. The records also include meetings William Barr attended, routine correspondence, correspondence involving an Office of Professional Responsibility (OPR) Report related to William Barr speech on juvenile justice, records related to National Security Decision Memorandum (NSDM) 119, a copy of the declassified NSDM-119 regarding disclosure of classified United States military information, memoranda from Brent Scowcroft to several members of the Presidential Cabinet regarding the 1991 and 1992 Global War Games, and records on the treatment of Salvadorian Nationals.
