System of Arrangement

Records that are responsive to this systematic project were found in one collection area-Bush Presidential Records: Staff and Office Files. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

Scope and Content

The materials in case number 2019-0542-S are a systematically processed body of cover sheets, administrative manuals, memorandum, and reports created and collected by the National Security Council. These records contain routing information, administrative information (such as travel and meeting arrangements, staffing issues, and records management), correspondence with Congress and executive branch agencies, draft documents (such as executive orders, press releases, and talking points), and unclassified reports and statements created for NSC meetings.

It should be noted that a significant number of the documents listed here are security classified and have been closed under the restrictions of the Freedom of Information Act.
