Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

Scope and Content

The materials in Case Number 2020-0360-S are a systematically processed body of documents responsive to the topic. Researchers should consult the archivist about related materials.

Case number 2020-0360-S contains materials from the files of Thomas E. (Ted) McNamara who served as Special Assistant to the President and Senior Director, African Affairs from June 1991 to October 1992.

The Staff and Office Files contain cables, memoranda, meetings minutes, presidential speeches/remarks, reports, and correspondence related to counternarcotics programs in Central and South America, the Andean Drug Summit, United Nations peacekeeping operations, Operation Restore Hope, National Security Review-27 (Low Intensity Conflict), and other issues of international import.
