## Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

## **Processed By**

Staff Archivists, December 2021. Previously restricted materials are added as they are released.

## System of Arrangement

Records that are responsive to this FOIA request were found in four collection areas—Bush Presidential Records: WHORM Alphabetical Files; Bush Presidential Records: WHORM Subject Files; Bush Presidential Records: Staff and Office Files; and Bush Vice Presidential Records: Subject Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental

processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at <a href="http://bushlibrary.tamu.edu/research/find/whorm/whorm.html">http://bushlibrary.tamu.edu/research/find/whorm/whorm.html</a>.

Please note that a single asterisk "\*" indicates that the category is entirely processed and open.

#### **Scope and Content**

The materials in FOIA 2020-0388-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2020-0388-F contains selected materials relating to the Reverend Billy Graham.

The White House Office of Records Management (WHORM) Alphabetical Files contain letters from the Billy Graham Evangelistic Association concerning the status of a refugee.

The WHORM Subject File categories contain correspondence and memoranda related to an interview President Bush gave about the Reverend Billy Graham.

The Staff and Office Files contain correspondence and memoranda related to an interview President Bush gave to Life Productions about the Reverend Billy Graham and a potential nomination for a Nobel Peace Prize.

The Bush Vice Presidential Subject Files contain an invitation to a Billy Graham crusade.
