#### **Extent**

340 folders

#### **Access**

Collection is open to all researchers. Access to Bush Presidential Records, Bush Vice Presidential Records, and Quayle Vice Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

#### **Copyright**

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

#### **Provenance**

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

#### **Processed By**

Staff Archivists, September 2021. Previously restricted materials are added as they are released.

#### **System of Arrangement**

Records that are responsive to this FOIA request were found in three collection areas—Bush Presidential Records: WHORM Alphabetical Files; Bush Presidential Records: WHORM Subject Files; and Bush Presidential Records: Staff and Office Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of

documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at <http://bushlibrary.tamu.edu/research/find/whorm/whorm.html>.

### **Scope and Content**

The materials in FOIA 2020-0560-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2020-0560-F contains materials from agencies and individuals including the White House, members of Congress, and members of the public.

The White House Office of Records Management (WHORM) Alphabetical Files contain articles, books, brochures, cards, envelopes, forms, identification cards, letters, memoranda, notes, papers, petitions, photographs, receipts, telegrams, and worksheets. Subjects covered include the general situation in Romania, Romanian orphans and struggles to adopt, assistance with personal issues involving Romania (healthcare, immigration, employment, etc.), "most favored nation" (MFN) trade status with Romania, economic assistance to Romania, and visa issuance.

The WHORM Subject File categories contain agreements, executive orders, forms, letters, memoranda, notes, press releases, and proclamations from the general public, Congress, and the Bush administration. Subjects include ambassador selection and resignations, "most favored nation" (MFN) status for Romania, and challenges faced by Romania after communist rule, the President's waiver of the Jackson-Vanik amendment of the Trade Act of 1974, an Agreement on Trade Relations between the United States and Romania, Romania's eligibility for U.S. Export-Import Bank support, and correspondence detailing trips to Romania by members of Congress and administration officials.

The Staff and Office Files contain articles, biographies, brochures, business cards, cables, envelopes, forms, letters, lists, memoranda, notes, papers, proclamations, reports, resumes, and treaties. Subjects include Romanian orphans; elections/politics in Romania; ambassadorial candidates, recommendations for ambassadorship, and personnel matters for ambassador to Romania; children's assistance organizations; relations between Moldova and Romania; forms such as personnel data forms, NSC/S Profile sheets, fax cover sheets, White House Correspondence Tracking Worksheets, and requests for appointments; economic assistance to Romania; immigration issues; support for MFN status for Hungary; an investment treaty with Romania; correspondence from the public regarding points for improvement in the U.S.-Romania relationship; and memoranda regarding trade agreements with Romania, ambassadorial nominations, Romanian children, legislative referrals, an investment treaty with Romania, meetings with Romanian officials, and observing elections in Romania. There are also papers detailing a trade agreement with Romania, the democratization process, and economic development in Eastern Europe. Included are a proclamation from the people of Romania, reports on ambassadorial nominations, Romanian children, meetings with Romanian officials, and U.S. assistance to Romania. These records also include a copy of the Treaty Between the Government of the United States of America and the Government of Romania Concerning the Reciprocal Encouragement and Protection of Investment.
