Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed By

Staff Archivists, December 2021. Previously restricted materials are added as they are released.

System of Arrangement

Records that are responsive to this FOIA request were found in four collection areas—Bush Presidential Records: WHORM Alphabetical Files; Bush Presidential Records: WHORM Subject Files; Bush Presidential Records: Staff and Office Files; and Bush Vice Presidential Records: Name File. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at <http://bushlibrary.tamu.edu/research/find/whorm/whorm.html>.

Please note that a single asterisk "*" indicates that the category is entirely processed and open.

Related Collections

Related material may be found in FOIA request 1998-0091-F entitled "HIV-AIDS Policy".

Scope and Content

The materials in FOIA 2020-0670-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2020-0670-F contains materials from agencies and individuals including the White House Office of Personnel, the Department of Health and Human Services (HHS), various medical/AIDS organizations, and private individuals.

The White House Office of Records Management (WHORM) Alphabetical Files contain letters from medical professionals and AID organizations dealing with the state of AIDS research, and from private individuals recommending Dr. Fauci for positions. Also included is a copy of Dr. Fauci's Curriculum Vitae and a photo of him.

The WHORM Subject File categories contain forms, letters, drafts, articles, and brochures concerning a message for the National Foundation for Infectious Diseases honoring Dr. Fauci with an award.

The Staff and Office Files contain evaluations forms and the Curriculum Vitae of Dr. Fauci.

The Vice Presidential Name File has correspondence between Vice President Bush and Dr. Fauci in the form of notes and memos.
