Access to Bush Presidential Records, Bush Vice Presidential Records, and Quayle Vice Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed By

Staff Archivists, May 2023. Previously restricted materials are added as they are released.

System of Arrangement

Records that are responsive to this FOIA request were found in seven collection areas—Bush Presidential Records: WHORM Alphabetical Files; Bush Presidential Records: WHORM Subject Files; Bush Presidential Records: Staff and Office Files; Bush Vice Presidential Records: Name Files; Bush Vice Presidential Records: Staff and Office Files; Quayle Vice Presidential Records: Staff and Office Files; and Federal Records. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it

frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at <http://bushlibrary.tamu.edu/research/find/whorm/whorm.html>.

Please note that a single asterisk "*" indicates that the category is entirely processed and open.

Scope and Content

The materials in FOIA 2020-0757-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2020-0757-F contains materials pertaining to the nation of Portugal, including U.S.-Portuguese relations.

The White House Office of Records Management (WHORM) Alphabetical Files contain correspondence from U.S. citizens and federal employees seeking assistance with the re-importation of personal property into the U.S. as well as opinions pertaining to U.S.-Portuguese affairs.

The WHORM Subject File categories contain memoranda, forms, and correspondence related to recommendations for appointments to the position of U.S. Ambassador to Portugal, expressions of gratitude for heads-of-state gifts between the nations, and general greetings from President Bush to be read before meetings of Portuguese-American interest group meetings, conferences, etc.

The Staff and Office Files consist of copies of official "Portuguese-American Month" proclamations, memoranda pertaining to ambassadorial nominations, and planning materials, schedules, etc. related to meetings with Portuguese officials and/ or trips to Portugal by Vice President Bush.
