#### **Access**

Collection is open to all researchers. Access to Bush Presidential Records, Bush Vice Presidential Records, and Quayle Vice Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

#### Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

#### **Processed By**

Staff Archivists, January 2022. Previously restricted materials are added as they are released.

#### **System of Arrangement**

Records that are responsive to this FOIA request were found in two collection areas—Bush Presidential Records: Staff and Office Files and Quayle Vice Presidential Records: Staff and Office Files. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

#### **Scope and Content**

The materials in FOIA 2020-0779-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2020-0779-F contains materials from agencies and individuals including the White House and the National Security Council.

The Staff and Office Files contain memoranda, notes, statements, and talking points. The Meeting Files of Virginia Lampley, a National Security Council (NSC) staff member who was the Senior Director for Legislative Affairs, consist of transmittal memos, talking points, and handwritten notes about a meeting between President Bush and bipartisan Congressional leadership. One of the topics covered in the meeting was talks with Shevardnadze. William Tobey's Subject Files contain copies of joint statements released after meetings in February 1990 between Secretary of State James A. Baker III and Soviet Foreign Minister Eduard Shevardnadze. Tobey was the Director of Defense Policy and Arms Control on the NSC staff.
