Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed By

Staff Archivists, December 2021. Previously restricted materials are added as they are released.

System of Arrangement

Records that are responsive to this FOIA request were found in four collection areas—Bush Presidential Records: WHORM Subject Files; Bush Presidential Records: Staff and Office Files; Bush Vice Presidential Records: Staff and Office Files, and Quayle Vice Presidential Records: Staff and Office Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the

incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at http://bushlibrary.tamu.edu/research/find/whorm/whorm.html.

Please note that a single asterisk "*" indicates that the category is entirely processed and open.

Scope and Content

The materials in FOIA 2021-0222-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2021-0222-F contains materials related to West German Defense Minister, West German Finance Minister, and UN High Commissioner for Refugees Gerhard Stoltenberg.

The WHORM Subject File categories contain records related to a meeting between FRG Defense Minister Stoltenberg and Brent Scowcroft.

The Bush Presidential Staff and Office Files contain correspondence, memoranda, and forms maintained by individual staff members and offices. These files from the National Security Council contain correspondence between President Bush and UN High Commissioner for Refugees Gerhard Stoltenberg, specifically about Indochina refugees. There are memos between NSC and State Department staff about the correspondence.

The Bush Vice Presidential Staff and Office Files contain documents related to Vice Presidential Meetings with FRG Minister of Finance Stoltenberg.

The Quayle Vice Presidential Records contain documents related to a meeting between Vice President Quayle and FRG Minister of Defense Stoltenberg.
