Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

System of Arrangement

Records that are responsive to this FOIA request were found in two collection areas—Bush Vice Presidential Records: Name File and Bush Vice Presidential Records: Subject File. As policy, WHORM Name Files and WHORM Subject Files are processed at the document level.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete

listing of the subject categories including a detailed description of each category is available in our research room and on our website at http://bushlibrary.tamu.edu/research/find/whorm/whorm.html.

Please note that a single asterisk "*" indicates that the category is entirely processed and open.

Scope and Content

The materials in FOIA 2022-0090-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2022-0090-F contains material related to John F. Lehman, Jr. during his tenure as Secretary of the Navy (1981–1987).

The White House Office of Records Management (WHORM) Name Files contain correspondence between secretary Lehman and Vice President Bush related to drug interdiction efforts in Florida, cordial greetings, and invitations to various navy-related events.

The WHORM Subject File categories primarily contain thank-you notes and letters for gifts received between Secretary Lehman and Vice President Bush, speaking invitations, and requests to attend navy ceremonies.
