## System of Arrangement

Records that are responsive to this FOIA request were found in one collection area—Bush Presidential Records: Staff and Office Files. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

**Scope and Content** These materials are found in the White House Social Office and contain gate lists, memorandum between the office staff members, and notes discussing phone calls to staff members and invitees to the White House dinner and viewing of *The Hunt for Red October* on February 19, 1990.

The materials in FOIA 2022-0234-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

The Staff and Office Files contain correspondence, memoranda, and notes maintained by Cathy Fenton and Laurie Firestone in the White House Social Office.
