Records that are responsive to this FOIA request were found in one collection area—Bush Presidential Records: Staff and Office Files. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

Scope and Content

FOIA 2022-0699-F contains materials from two National Security Council staff members, Richard L. Canas, director of Counterterrorism and Counternarcotics, and Virginia A. Lampley, special assistant to the president for national security affairs and senior director for legislative affairs. These materials include talking points for the President and Press Secretary on the arrest of Minister Arce-Gomez as well as the emergency authorization and furnishing of U.S. military assistance to Colombian law enforcement agencies; copies from Elaine Shannon's *Desperados: Latin American Drug Lords, U.S. Lawmen, and the War American Can't Win;* coversheets for Department of State telegrams and correspondence routing slips; and draft and final memoranda notifying Congress of the Presidential Determination 89-24.
