Scope and Content

The materials in Case Number 2022-0746-S are a systematically processed body of documents responsive to the topic. Researchers should consult the archivist about related materials.

2022-0746-S contains material from the files of National Security Council staff member Richard C. Barth who served as Director, International Economic Affairs from May 1990 until October 1992 (Portfolio: Export Controls, Technology, Missile Proliferation).

The Staff and Office Files contain memoranda, reports, cables, and correspondence pertaining to U.S. trade/export controls over militarily sensitive technologies within the context of the Coordinating Committee for Multilateral Export Controls (CoCom), a post-World War II agreement among Western Bloc nations. Included in the materials are discussions and negotiations between the U.S. and other CoCom nations regarding items/technologies which should or should not remain on the various control lists which prevented their exportation to the Soviet Union/Eastern Bloc as well as nations designated as state sponsors of terrorism.
