## **Biographical Note**

A native of Philadelphia, Pennsylvania, Virginia Lampley was educated at Miami University in Ohio and Georgetown University. She served as an officer in the U.S. Air Force with assignments in various intelligence positions and within the office of legislative liaison. On March 13, 1989, President Bush appointed Lampley as the Special Assistant to the President for National Security Affairs and Senior Director for Legislative Affairs on the National Security Council. Previously, she had served as a client executive with DGA International, representing international corporations within the United States. Lampley resigned on November 4, 1992.

## **Scope and Content**

The materials in this collection are a systematically processed body of documents responsive to the topic. Researchers should consult the archivist about related materials.

These records consist of correspondence, reports, agendas, memoranda, meeting minutes, lists, and statements of administration policy concerning legislative actions by the U.S. Congress that the President determined affected national security and were coordinated through the National Security Council.

It should be noted that a significant number of the documents listed here are security classified and have been closed under the restrictions of the Freedom of Information Act.
