Biographical Note

Richard L. Canas served as Director for Counternarcotics and Counterterrorism from 1990 to 1994. His primary areas of responsibility included drug control policy, drug interdiction, and border control. He served as a Special Agent with the Drug Enforcement Agency from 1972 to 1996 and as Director of the National Drug Intelligence Center at the Department of Justice from 1996 to 1998.

Scope and Content

The materials in this collection are a systematically processed body of documents responsive to the topic. Researchers should consult the archivist about related materials.

Case Number 2022-0927-S contains correspondence, papers, printed material, speeches and talking points addressing topics such as counternarcotics, counterterrorism, border security, hostages, and low-intensity conflict.

It should be noted that a significant number of the documents listed here are security classified and have been closed under the restrictions of the Freedom of Information Act.
