System of Arrangement

Records for this systematic project were found in the following collection area—Bush Presidential Records: Staff and Office Files. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

Biographical Note

The Office of Cabinet Affairs served as the administrative arm of the Office of the Cabinet Secretary. The Director of Cabinet Affairs was responsible for the day-to-day operations of the office, including personnel issues and staff activities. In June 1991, Gary R. Blumenthal was named Deputy Assistant to the President for Cabinet Liaison and Special Assistant to the President for Agricultural Trade and Food Assistance. He remained in that position until January 20, 1993.

Scope and Content

The materials in Case Number 2023-0133-S are a systematically processed body of documents responsive to the topic. Researchers should consult the archivist about related materials.

These records consist of memos, letters, notes, documents, news releases, magazine and newspaper articles, and White House forms.

The bulk of this collection consists of memos covering a variety of topics including accomplishments related to the Asia Pacific Economic Cooperation Ministerial held in Seoul, President Bush's views on Uruguay Round issues, USTR and Commerce trade determinations on international products, intellectual property negotiations, Uruguay Round reports, agricultural export credit guarantees, international market access barriers, U.S. patent infringements, meetings with foreign heads of state and trade officials, GATT (General Agreement on Tariffs and Trade) and NAFTA (North American Free Trade Agreement) discussions, trade enhancement issues, international consensus against the trafficking and use of drugs, an Export Enhancement Package for Central and Eastern Europe, Economic Policy Council meetings and the topics of discussion, the Omnibus Trade and Competitiveness Act of 1988, environmental issues, the automobile industry, the President's Award for Distinguished Federal Civilian Service, border security, impacts of fuel prices on the aviation industry, and the Agency for International Development programs in Central America. The letters are mainly ones between President Bush and leaders of the United States House of Representatives regarding the administration's stance on NAFTA. The notes are between staffers discussing routed documents and recommended actions. The documents include issue papers on U.S. trade policies, economic impacts of a NAFTA, free trade negotiation points, Enterprise for the Americas, and a trade issues fact sheet. The news releases announce international trade determinations, trade enhancement initiatives, and information about the Uruguay Round. The magazine and newspaper articles cover fuel price hikes effects on airlines and international economic policy. The White House forms consist of routing slips which track who send and receive forwarded documents, and Staffing Memoranda that request comments and recommendations from White House officials on attached documents.
