Heather Wilson served as Director for European Defense Policy and Arms Control from 1989 to 1991. Her primary areas of responsibility included Germany, the USSR, Conventional Forces in Europe (CFE), Great Britain, and NATO. Wilson was an Air Force officer from 1982 to 1989. In 1998, she was elected to the U.S. House of Representatives, where she served until 2009. In 2017, she became the 24<sup>th</sup> Secretary of the United States Air Force.
