Biographical Note

Susan Koch served as Director for Defense Policy and Arms control in 1992. Her primary areas of responsibility included nonproliferation, warhead reduction and the Strategic Defense Initiative (SDI). In addition to her work at the NSC, between 1982 and 2007 Koch held various senior positions at the Office of the Secretary of Defense, the Department of State, and the U.S. Arms Control and Disarmament Agency working primarily on nonproliferation and arms reduction policy.

Scope and Content

The materials in this collection are a systematically processed body of documents responsive to the topic. Researchers should consult the archivist about related materials.

Case Number 2023-1094-S contains cables, correspondence, papers, press releases, printed material, repots, and talking points addressing topics such as arms control, Conventional Forces in Europe (CFE), defense preparedness, export controls, nonproliferation, nuclear testing, and the Strategic Arms Reduction Treaty (START).

It should be noted that a significant number of the documents listed here are security classified and have been closed under the restrictions of the Freedom of Information Act.
