Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

Scope and Content

Case number 2023-1135-S contains materials from the files of John F. McShane who served on the National Security Council staff as Director, Latin American Affairs from April 1992 to October 1992.

The Staff and Office Files contain memoranda, correspondence, reports, etc. pertaining to U.S.-Latin American policy including the negotiations with Mexico surrounding the North American Free Trade Agreement (NAFTA), the repatriation of Haitian immigrants ("Haitian Boat People"), and U.S. relations with other Latin American nations.
