Biographical Note

Captain David J. McMunn (U.S. Navy, Retired) served as Director of Border Security for the White House (1990–1991), implementing the recommendations of the Vice President's Task Force on Border Security (1988–1989). He also served on the Vice President's Task Force on combating Terrorism (1985–1986). Among his many duties in the navy, he served as Assistant Chief of Staff for Intelligence, U.S. Atlantic Fleet (1986–1989) and as Naval Attaché, U.S. Embassy, Israel (1975–1978).

Scope and Content

The materials in Case Number 2023-1138-S are a systematically processed body of documents responsive to the topic. Researchers should consult the archivist about related materials.

Case Number 2023-1138-S contains materials from the files of Capt. David J. McMunn during his tenure as Director of Border Security for the White House.

The Staff and Office Files contain memoranda, reports, and papers pertaining to U.S. border security, including customs procedures, drug interdiction policies, etc., including memoranda and notes taken by Capt. McMunn during trips to several border stations. (Also included are administrative materials such as itineraries, receipts, travel orders, etc.) The materials also contain various iterations of immigration reform legislation and agency comments/ suggestions regarding the proposals. A significant amount of the records consists of memoranda, reports, and correspondence from various affected government agencies related to the recommendations and findings presented by the President's Commission on Aviation Security and Terrorism.
