

Kennebunkport, Maine

The President called President Aquino to congratulate her on recent signing of base agreements and to discuss events in the Soviet Union. (S)

The President: Hello? (U)

President Aquino: Hello Mr. President. (U)

The President: How are you? I am delighted to hear from you. (U)

President Aquino: You are looking well, I have seen you on the TV and you look good. (U)

The President: Well, thank you. We are having a good vacation although it has been interrupted by Soviet matters, as everyone's has been. Well, I am delighted we have been able to successfully complete the Treaty. (U)

President Aquino: Yes, we finally signed the Treaty of Friendship, Cooperation and Security, but we are facing an uphill battle in the Senate. [REDACTED]






The President:
