

Prime Minister Rabin called the President. (U)

Prime Minister Rabin: Hello, Mr. President. (U)

President Bush: Well, it is nice to hear your voice. (U)

Prime Minister Rabin: Pleasant to hear from you. I didn't want to bother you right after the elections. I felt I had to talk with you and tell you how much I appreciate what you have done for the state of Israel. In time, many things you've done will be seen to have been courageous for Israel's security and its future. My wife and I are grateful to you and Mrs. Bush for Kennebunkport. It was a real pleasure for both of us. (U)

President Bush: Aren't you nice to call. It has been unpleasant for me here. I am sure that Governor Clinton will be working closely with you. We tried hard in promoting peace in the Middle East. It is hard to say anything right now because everyone is so negative. But with time this will change. I really appreciate your call. (U)


Prime Minister Rabin: In the meantime, we will continue with the negotiations. I really appreciate all you have done. (U)

President Bush: I am glad that the talks are going on. I understand you have had some border activities. (Ø)

Prime Minister Rabin: In a way yes, (b)(1) guidance of Iran, without Syria trying to stop them, has been active. I will not allow this to interfere with the peace process. (Ø)

President Bush: That's good. I am sorry you have had this worry. (b)(1)
