

The President: It is so nice of you to call. Brent Scowcroft told me your Ambassador said you would be calling. It has been a gloomy week here, but I am cheered up by good friends like yourself.  $(\mathcal{Q})$ 

<u>King Fahd</u>: I am happy to hear your voice. ( $\mathscr{D}$ )


The President: It is wonderful to hear from friends. Now, Mrs. Bush and I are thinking about the future back in Texas. (2)

<u>The President</u>: It was nothing at all. It was sweet and kind of you to call. I look forward to seeing you whenever you are in the U.S. Even though I am out of public life, I hope to see you wherever you might be in our country, and I hope that you will honor us by a visit to our house in Maine. You are a friend, and I will never forget it.  $(\mathbf{y})$ 

<u>King Fahd</u>: Thank you. I will be visiting a dearest friend, and we will do that.  $(\mathbf{y})$ 

The President: Thank you. Now I will finish this job and head back to Texas on January 20. (9)

King Fahd: God be with you. May he grant you happiness and health. (U)

The President: Thank you very much and good bye. (U)
