



Pleasantries were exchanged during a photo op, but no questions were taken. (U)

The President: I am delighted to see you and to have your assessment of the world and the Middle East. (Ø)

President Herzog: I am happy to be here. Let me first of all express appreciation for your leadership during Desert Storm. I recall that we talked just before you decided to move. I also want to express appreciation for your efforts in the Middle East peace process. It is something that has its ups and downs like the stock market. We have a very good team here and are working with the Arabs. (Ø)



The President: Have we seen any results from the Peres visit to Egypt? (Ø)

Mr. Hull: Both Peres and Mubarak stressed regional economic development and peace as a prerequisite. (Ø)

President Herzog: We have a relationship there, too. The other day, for example, I was having a lunch for an Indian delegation. Foreign Minister Peres was called out to take a call from (Egyptian Foreign Minister) Moussa. You have had much to do with these developments, and I made a point of that in my speech to the General Assembly of Jewish Federations. (Ø)


The President: We are now in a transition period here. I believe the United States will continue to play a role as catalyst. I will be meeting with President-elect Clinton Wednesday, and I will discuss the Middle East peace process at that time. (S)

Mr. Baker: Except for Iraq, the Middle East was not an issue in the campaign. I spoke with former President Carter at an airport last September. He told me he made a point with Mr. Clinton of the importance of continuity in the Middle East and expected it would be the case. (S)

The President: I take it Mr. Shamir was not too happy with me, judging from a comment I saw recently. (S)


President Herzog: You are in good company. (S)

The President: Sometimes you just have to do what you have to do. (S)




The President: How is Arafat's health? (U)


President Herzog: He had some treatment in Amman. You know I am friends with his mother-in-law, Raymonda Tawil. She is very able. (✓)

Mr. Hull: Recent reporting suggests Arafat is better. He is travelling again. But he still has trouble concentrating. (✓)

The President: What is your schedule now? (S)

President Herzog: Back to New York then to Israel. Next Monday President Mitterrand will be visiting. (S)

The President: We have our problems with the French, but I enjoy a pleasant personal relationship with him. He has terrible political problems. But, tell him to do something on the GATT. It will help everyone, especially the Third World. (S)

President Herzog: We have a conference the following day on the European market. Maybe I will have a chance to say something there. He is also going to see King Hussein. (S)

The President: Will he go elsewhere? (S)


President Herzog: It seems Israel then Jordan. (S)

The President: Well, it was nice of you to come by, and I am pleased to see you. (S)

President Herzog: I just want to tell you that you have entered history, especially with your stand on the Gulf War. I remember sending you a psychological portrait of Saddam Hussein. (S)

The President: I will have to pull it down and look at it. I assume it had only bad things in it because this guy is awful. (S)
