

Draft Presidential Message to the Amir of Kuwait

I am deeply grieved by the despicable Iraqi invasion of your country. It is a relief to hear that you are safe, and I want you to know how strongly I feel about the need to restore Kuwaiti sovereignty over its full territory.

Last night I directed our Ambassador to the United Nations to work closely with yours to make clear to the world our uncompromising opposition to Iraq's actions. We will continue to work together to garner international condemnation of the invasion. I continue to follow closely the situation, and I have directed my closest advisors to consider all options.

I will stay in touch with you and our other friends.
