SUBJECT: Schedule Proposal for Prince Hans Adam II of Liechtenstein

You had asked that we prepare a Schedule Proposal for Prince Hans Adam. We had proposed to the Liechtensteiners that the meeting be held in New York so as to minimize the intrusion on the President's schedule. This will not work, as the Prince will be in California through September 24.

Should you wish to pursue the matter and arrange a meeting in Washington, September 25-27, we have prepared a Schedule Proposal. (We have no reason to recommend a meeting but understand there may be domestic considerations.)

RECOMMENDATION

Should you wish to arrange a White House meeting with the Prince, that you sign the Schedule Proposal at Tab I.
