Dear Mr. President:

I am writing to request that the NRM Corporation of Ohio receive all possible assistance in recovering its losses brought about by the sanctions against Iraq. I have a relative who is now out of work because NRM has had to absorb a \$14 million loss on custom-built equipment for Iraq. Many other Americans are dependent upon the company's three plants which have closed and the subcontractors and suppliers which are affected.

The NRM Corporation cannot load the equipment on to the ship and thus cannot receive the on board bill of lading needed to obtain payment from the Commercial bank of Kuwait, New York Branch. This bank has already guaranteed payment by a confirmed letter of credit (number 03988).

I am asking that all possible efforts to obtain payment for the Iraqi equipment be taken. The letter you have already received from several of my colleagues proposes exchanging the equipment for the money already in the bank. This seems to be a reasonable solution allowing NRM to recover its loss. However, other solutions may be also available.

I would appreciate your immediate attention to this problem.





Dear Mr. President:

I am writing to request that the NRM Corporation of Ohio receive all possible assistance in recovering its losses brought about by the sanctions against Iraq. I have a relative who is now out of work because NRM has had to absorb a \$14 million loss on custom-built equipment for Iraq. Many other Americans are dependent upon the company's three plants which have closed and the subcontractors and suppliers which are affected.

The NRM Corporation cannot load the equipment on to the ship and thus cannot receive the on board bill of lading needed to obtain payment from the Commercial bank of Kuwait, New York Branch. This bank has already guaranteed payment by a confirmed letter of credit (number 03988).

I am asking that all possible efforts to obtain payment for the Iraqi equipment be taken. The letter you have already received from several of my colleagues proposes exchanging the equipment for the money already in the bank. This seems to be a reasonable solution allowing NRM to recover its loss. However, other solutions may be also available.

I would appreciate your immediate attention to this problem.

Thank you for your letter of December 17, 1991, which was forwarded from the White House through the State Department to the Department of the Treasury. You requested that every effort be made to assist NRM Steelastic, Inc., in securing payment for equipment it custom-made for Iraq prior to Iraq's invasion of Kuwait in August 1990.

Within weeks after the invasion, the Office of Foreign Assets Control (FAC) of the Treasury Department licensed payment of up to \$10,814,046.90 to NRM for goods it had shipped to Iraq. FAC has had the opportunity to examine the remainder of NRM's request for a license in depth, and has determined that further accommodation is inconsistent with United States Government policy. NRM was not able to complete shipment of the goods in question, and were FAC to allow them to satisfy this claim using blocked funds, the U.S. Government would place NRM in a preferred position relative to other victims of the invasion.

The United Nations Compensation Commission is developing forms and guidelines for the collection of claims by corporations. FAC has forwarded NRM's address to the Assistant Legal Adviser for International Claims and Investment Disputes (L/CID), Department of State, who will be administering the U.S. portion of the international claims process. Dear Mr. President:

I am writing to request that the NRM Corporation of Ohio receive all possible assistance in recovering its losses brought about by the sanctions against Iraq. I have a relative who is now out of work because NRM has had to absorb a \$14 million loss on custom-built equipment for Iraq. Many other Americans are dependent upon the company's three plants which have closed and the subcontractors and suppliers which are affected.

The NRM Corporation cannot load the equipment on to the ship and thus cannot receive the on board bill of lading needed to obtain payment from the Commercial bank of Kuwait, New York Branch. This bank has already guaranteed payment by a confirmed letter of credit (number 03988).

I am asking that all possible efforts to obtain payment for the Iraqi equipment be taken. The letter you have already received from several of my colleagues proposes exchanging the equipment for the money already in the bank. This seems to be a reasonable solution allowing NRM to recover its loss. However, other solutions may be also available.

I would appreciate your immediate attention to this problem.
