Topics and groups discussed include: Opticians Association of Michigan; Physicians Comparability Allowances Reauthorization; Indian American Physicians; Student Osteopathic Medical Association; The Access to Health Care Act of 1991; Health Care Liability Reform & Quality Care Improvement Act of 1991; Medical Malpractice; Dental Technology Week; "Changing Physician/Client Relationships"; Secretary's Commission on Nursing - 3 Volumes; American Nurses Association; National

Federation of Licensed Practical Nurses, Inc. (NFLPN), and Reauthorization of the Nursing Shortage Reduction & Education Extension Act of 1988.
