#### Extent

#### Access

Collection is open to all researchers. Access to Bush Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

#### Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

#### Provenance

Official records of George Bush's presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

#### Processed By

Staff Archivists, 1996–1997. Previously restricted materials are added as they are released.

#### Scope and Content

The materials in WE (Welfare - General) are a systematically processed body of documents from the White House Office of Records Management (WHORM) Subject File. This primary category containing general information on welfare including correspondence between President and Mrs. Bush and constituents, organizations, religious groups, and Congressmen and internal memoranda between the President and his advisors regarding liability protection for volunteers, nominations for the 1,000 Points of Light Initiative, the Barbara Bush Literacy Foundation, the Family and Medical Leave Act, and the National Community Service Act. This category also contains letters, reports, and telegrams to President and Mrs. Bush concerning international welfare, rural poverty, corporate giving, children's rights, drug and alcohol

abuse, special education, and federal waivers of state welfare requirements.

**System of Arrangement**

Records that are responsive to this FOIA request were found in Bush Presidential Records: WHORM Subject Files.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category.
