#### Access

Collection is open to all researchers. Access to Bush Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

#### Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

#### Provenance

Official records of George Bush's presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

#### Processed By

Staff Archivists, 1996–1997. Previously restricted materials are added as they are released.

#### Scope and Content

The materials in FE006 (National Emblems) are a systematically processed body of documents from the White House Office of Records Management (WHORM) Subject File. This secondary subject category contains materials relating to use of the President's Seal and signature and protocol and so forth with respect to the national anthem. For example, one individual sends in a letter in which he requests permission to replace a replica of the Seal of the President displayed at the JFK Memorial Wall in Parkland Memorial Hospital in Dallas, Texas. In another case, a young boy admonishes Bush for not placing his hand over his heart during the playing of "The Star Spangled Banner." Some of the same matters covered here (i.e. protocol and the President's Seal) would seem to be dealt with at least in part in

previous file codes. Such an arrangement could pose problems for the researcher.

**System of Arrangement**

Records that are responsive to this FOIA request were found in Bush Presidential Records: WHORM Subject Files.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category.
