#### Extent

#### Access

Collection is open to all researchers. Access to Bush Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

#### Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

#### Provenance

Official records of George Bush's presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

#### Processed By

Staff Archivists, 1996–1997. Previously restricted materials are added as they are released.

#### Scope and Content

The materials in FE010-01 (Access to Records - Documents) are a systematically processed body of documents from the White House Office of Records Management (WHORM) Subject File. This secondary subject category contains materials relating to principally Freedom of Information/Privacy Act (FOI/PA) requests. Many times people want any records that might be available concerning themselves. Historians and other researchers are seeking valuable documents about key individuals, some of whom have been dead for decades. Others just want to annoy archivists and FOI/PA officers by making requests they know have no chance of being fulfilled. In addition, in this subject code on numerous occasions the head of Presidential Libraries notifies the President's Counsel (C. Boyden Gray) that papers from the Nixon and

Reagan Libraries are going to be opened for research. He then asks whether or not Bush wants to claim executive privilege in any instance and keep specific records closed.

**System of Arrangement**

Records that are responsive to this FOIA request were found in Bush Presidential Records: WHORM Subject Files.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category.
