Access to Bush Presidential Records, Bush Vice Presidential Records, and Quayle Vice Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed By

Scope and Content

The materials in FOIA 2012-3070-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials. FOIA 2012-3070-F contains material submitted to the White House by the Resolution Trust Corporation, a U.S. government-owned asset management company that operated from 1989 through 1995. The WHORM Subject File FG479 contains cover sheets for transmitting bound volumes to the White House. The bound volumes, the Resolution Trust Company's June 30, 1991, Real Estate Asset Inventory (Vol. I – Commercial Properties; Vol. II, Parts 1-4 – Residential Properties; and Vol. III – Land), are publicly

available. A set is available to researchers as part of the book collection in the George Bush Presidential Library Research Room.

System of Arrangement

Records that are responsive to this FOIA request were found in one collection area—Bush Presidential Records: WHORM Subject Files. As policy, WHORM Subject Files are processed at the document level. The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category.
