The materials in HE001-06 (Physically Handicapped) are a systematically processed body of documents from the White House Office of Records Management (WHORM) Subject File. This secondary subject category contains information about programs, reports and various other information on the handicapped such as: hearing impaired & blind; federal disabilities programs; Talking Books Program; National Commission on Education for the Deaf; Americans with Disabilities Act; Helen Keller National Center for Deaf - Blind Youths & Adults; Temporary Handicapped Children's Child Care & Crisis Nurseries Act - Respire Program; Project ORBIS - Flying Eye Hospital; Center for the Visually Impaired; Deaf Awareness Week; spinal muscular atrophy; lip reading or speechwriting; National Multiple Sclerosis Society of 1988

Annual Report; handicapped & disabled persons - "Dwarf Community;" and several reports from MDA - To Assure the Free Appropriate Public Education of all Handicapped Children, 1988-90; Education for Hearing Impaired; Central Florida Lions Eye & Tissue Bank; retinal diseases, and judicial duties of a blind person.
