#### Scope and Content

The materials in HE005 (Hospitals) are a systematically processed body of documents from the White House Office of Records Management (WHORM) Subject File. This secondary subject category contains information about hospital policies, programs, and reports. Topics include: A letter and reports on Prenatal Care National Network to Prevent Birth Defects; Hospital News Delaware Valley; "Chernobyl Aid Plan - Children of Chernobyl;" Hospital Cost Containment in the 1990s; employment of people with disabilities; veterans hospitals; National Leadership Coalition for Health Care Reform; Clinical Laboratory Improvement Amendments (CLIA) of 1988; Regulations on those Previously Unregulated Physician Office Laboratories; hospital care and costs; ALSAC - St. Jude Children's Research Hospital 1989 Annual Report;

and Medicare Catastrophic Coverage Repeal Act of 1989.

**System of Arrangement**
